1. RECONNAISSANCE

1.1 Reconnaissance is permitted on Saturday 30th March

1.2. Reconnaissance is only permitted between the hours of **9:30** and **15:00**.

Any competitor (driver or co-driver) found to be carrying out Reconnaissance on any date or time outside of this time without written permission from the Clerk of the Course will be penalised in accordance with the Event Supplementary Regulations.

1.3 Crews should ensure they comply with the Supplementary Regulations paragraphs applying to Reconnaissance (Paras 6.1.1 – 6.1.19)

1.3. Reconnaissance Sign-On will take place between the hours of 09:00 and 11:00 dates, at the Dennett Interchange, 1 Brook Rd, Donemana/Dunamanagh, Strabane BT82 0PF, GPS N91 54°52'20.7" W7°18'38.7"

1.4. Judges of Fact will be present on all stages throughout the scheduled Reconnaissance time to observe driving standards. A list of named Judges of Fact will be displayed on the Event Official Notice Board.

1.5 The maximum number of passes per special stage is two.

1.6 At Reconnaissance Registration all Competitors must provide details of the reconnaissance car and occupants, including address and telephone numbers at which they can be contacted during the reconnaissance period. This must be submitted to the organisers for registration at the signing on.

1.7 While engaged in reconnaissance the Reconnaissance Car Plate must be displayed on the top corner of the windscreen of the car. Failure to do so will be deemed to be a breach of the reconnaissance regulations.

1.8 Insurance Scheme details

The Organisers have applied to Jelf Insurance Partnership for a Blanket Cover Notes under the above scheme, both for **Recce Cover (30th March) and Rally cover (6th April)**. This will provide competitors with the Third Party Cover necessary to meet RTA requirements on the Road Sections of the event.

Any loading fee above the basic rate must be paid at Recce Sign-on prior to the start of the event.
